CALL TO ORDER

Mayor Busby called the Town Council meeting to order at 6:57 P.M. with Mayor Pro-tem Davis, Councilman Simpson, Echerer and Dinkins present.

INVOCATION

Councilman Simpson led those assembled in prayer.

APPROVAL OF MINUTES

1. July 12, 2011 Regular scheduled Council Meeting

Councilman Dinkins made the motion to accept the minutes of July 12, 2011 be approved as submitted. Councilman Simpson seconded the motion, which was unanimously approved.

OLD BUSINESS

1. Map Amendment Ordinance 2009-04 for TMS# 007833-01-009

Mayor Busby read Ordinance 2009-04 that was approved for first reading on July 12, 2011.

Councilman Dinkins made a motion to accept Ordinance 2009-04 as read. Mayor Pro-tem Davis seconded the motion, which was unanimously approved.

Council discussed the rain garden, municipal sewer hook-up costs, DHEC, DOT, residential well water, Comprehensive Plan, previously installed sewer system.

Councilman Echerer made a motion to amend Ordinance 2009-04 to remove the mandatory municipal sewer connection for any and all construction. Mayor Pro-tem Davis seconded the motion.

Mayor Busby called for a vote to approve Map Amendment Ordinance 2009-04 as follows:

C-1 (PD)

Any and all planning and construction must be pre-approved through the Town of Pine Ridge Planning Commission with final approval given by Town Council.

A can not build past line of no more than three hundred feet paralleling Pine Ridge Drive is established which prohibits the construction of any commercial building beyond the can not build past line.

No exits from the commercial property will be allowed, with the exception of any requirements by SCDOT under State law, and if exits are required, they must be right turn only so as to direct traffic toward Pine Ridge Drive.

All commercial lighting must be installed according to a Lexington County approved lighting plan, which restricts the amount of diffused light that might affect adjoining residential areas.

Landscape buffers of no less than fifty (50) feet along the rear property line and no less than twenty-five (25) feet running parallel with Courtney Drive are required.

The use of Rain Gardens, where feasible, will be used for stormwater management practices to reduce or eliminate stormwater detainment facilities.

Furthermore Council is requiring the above mentioned stipulations to be incorporated into any and all deeds for TMS# 007833-01-009, to be recorded as deed restrictions.
