CALL TO ORDER

Mayor Busby called the Town Council meeting to order at 7:05 P.M. with Mayor Pro-tem Davis, Councilman Dinkins, and Councilman Price and Councilman Wells present.

Councilman Dinkins led those assembled in prayer.

APPROVAL OF MINUTES

1. August 14, 2012 Regular scheduled Council Meeting

Councilman Dinkins made the motion to accept the minutes of August 14, 2012 be approved as submitted. Councilman Wells seconded the motion, which was unanimously approved.

Councilman Wells made a motion to amend the minutes of August 14, 2012 to correct it to read "Congaree Baptist Church", under Informational Council Discussion. Councilman Price seconded the motion, which was unanimously approved.

OLD BUSINESS

1. Fire Hydrant Expansion Project

Mayor Busby asked for a formal motion to begin talks with Cayce to talk about engineering, ownership, etc. Mayor Busby asked Councilman Wells to help with the talks and construction project since he has extensive background in this area.

Mayor Busby would like to follow up with Senator Setzler and Representative Toole on purchasing Camp Styx Historical Park.

3. Finance Committee Recommendations - Donation Policy

3. Resolution 2012-10 Support John Hardee Expressway

Lexington County has asked all Municipalities for their support. The Economic Development Committee had promised Amazon/Nephron the expressway. Mayor read aloud Resolution 2012-10.

Councilman Wells made a motion to approve Resolution 2012-10 as submitted. Councilman Dinkins seconded the motion, which was unanimously approved.

4. Website update - Business License

Councilman Price made a motion to approve the \$100 cost of creating a new page on the website. Councilman Wells seconded the motion, which was unanimously approved.
